1. About These Terms

Welcome to Women Woke Within. These Website Terms, Conditions & Privacy Statement (collectively, the “Terms”) govern your access to and use of womenwokewithin.com and the content, features, forms, publications, directories, advertising information, and other services made available through the website (the “Website”). Women Woke Within Corporation is a for-profit corporation organized in the State of Georgia (“Women Woke Within,” “we,” “us,” or “our”).

By accessing or using the Website, you agree to these Terms. If you do not agree, please do not use the Website. Certain services, submissions, advertising arrangements, interviews, partnerships, or other programs may be governed by separate written agreements in addition to these Terms.

2. Our Purpose and Website Content

3. Eligibility and Acceptable Use

You must be at least 18 years old, or the age of legal majority in your jurisdiction, to submit forms, enter agreements, purchase services, or provide content through the Website.

You agree to use the Website lawfully and not to:

We retain information for as long as reasonably necessary for the purposes described in this Statement, to maintain appropriate business records, and to meet legal or contractual obligations. We use reasonable administrative and technical measures intended to protect information; however, no website, internet transmission, or electronic storage system can be guaranteed to be completely secure.
